Additionally, the Task Force is supported by two subcommittees, one focused on the Environmental Health Disparities Map and the other concentrating on community engagement among historically marginalized populations and highly impacted communities. Both subcommittees have their own set of objectives and will recommend model policies and measureable goals for reducing environmental health disparities. Subcommittees will meet monthly to collaborate on current efforts, present findings, and share resources.
