During intense and well though out community meetings, we are recommending and demanding equality in all ares of the cannabis industry. Equality in licensees, capitalization, location availability, community development fund, also the full process.

We feel the majority folk on the task force agree and statistics show that African-Americans are discriminated against more than any other race by a enormous percentage gap. As we plowed through this journey to create equity, equality and economical justice, we must assure we do not leave out the African American community by large. Currently the bill reads:

### 1443

"Must have a conviction of a drug offense of an applicant, or family member of an applicant, is a qualifying factor to be considered a social equity applicant, subject to other conditions. An individual must have lived in a disproportionately impacted area for a period of time defined in rule by LCB"

There are current recommendations to expand the language however the community at large is being left out. If you're African-American, you've been intensely discriminated against no matter where you live or have lived. No

matter if you had a drug offense or not. If you lived in anglo-Saxon community you're discriminated against and targeted because you're living in a anglo-Saxon community, and if you lived in a African American community, the whole community is targeted and abused. The point is, the only qualification you have ever needed to be discriminated against if your African American, is to be African American. It doesn't matter where you live, what profession your in, or if you have a arrest record or not. The areas that are predominantly African-American obviously were and are targeted areas and should receive top consideration along with folk arrested from the war on drugs, however; The community strongly feels being African American should be a qualification no matter where you live or have lived, justifiably so. A person should qualified to submit a application if they

1) lived in a area targeted by the war on drugs, 2) have a drug offense, or 3) are African-American.

As we advocate and demand equity and equality for the equal number of licenses, capitalization, Community development fund, we also demand equity and equality for all African-Americans that have been victimized for 580 years.

Let's continue to aggressively unite to do the right thing. Being African-American needs to be added on to the scoring process as one of the three qualifications needed to apply.

### To All:

We want to express to everyone direct that our positions have not changed on any of the points that have been communicated to the task force and workgroups. Most points have been voted on by the workgroups to be recommended by the task force.

We have recently experienced fierce pressure for the community to change our position on the community reinvestment program, that will not happen. The states budget is approximately 47 billion dollars annually and they're applying pressure for the community to change our position from demanding 50% of the state cannabis tax money for the community reinvestment program. Currently that represents approximately \$250 million annually to the black and brown communities out of the states \$47 billion annual budget, thats a drop in the bucket.

The Native Americans received \$1.9 billion last year from net receipts from gaming. They also are furthering their bottom line profits by the legislation and governor signing a bill in March 2020 allowing sports betting in the Native Americans casinos. The Government celebrated signing that bill. Equity, equality, economic justice is well deserved for the Native American communities.

## Washington Governor Jay Inslee signs 15 tribal sports wagering compacts

Obviously the state understands how to issue equity, equality, and economic justice; however the State of Washington wants nothing to do with TRUE equity, equality, economic justice for the African American and Hispanic communities. As our voice gets louder our push will get harder. We will not be intimidated, and we will not be bullied, and anyone that try's will be dealt with. We will also not be misrepresented. Mr. Buchanan - As I've shared with you before, the recommendations that we've negotiated thus far in the various workgroups within the Cannabis task should not be rescinded. In fact they don't go far enough.

## **Community Representation**

The NAACP represents 13 local branches throughout the northwest region, seven in Washington State.

Our branches serve the African American and other communities of color in the most populated counties, (King, Snohomish, Pierce, Spokane, Clark, Kitsap, and Yakima) in Washington. We have had a front row seat witnessing the devastation that policies like The War on Drugs, Weed and Seed and Stop and Frisk type of programs have had on our communities for generations.

### **NAACP** Position

**Engrossed Substitute House Bill 1443, entitled** – An Act relating to social equity within the cannabis industry.

**Engrossed Second Substitute House Bill 2870, entitled** – An Act relating to allowing additional marijuana retail licenses for social equity purposes.

The above Bills highlight social equity as a goal, but do not include much of what the community deems as racially or socially equitable. We have been working with community organizations who are well versed in the Cannabis ecosystem to ensure we understand the limitations of HB 1443 and HB2870, as well as opportunities to revise said legislation.

We come in Peace now, but are prepared to fight for what should be an adequate economic response to begin to repair our community.
