#### **Executive Order 22-04**

• Establishes a new Pro-Equity Anti-Racism (PEAR) Plan and Playbook for state agencies.

• Roles:

- Agencies accountable for achieving PEAR outcomes.
- Office of Equity provide tools, guidance, assistance, and training
- <u>Watch</u> Governor Inslee sign <u>Executive Order 22-04</u>.

## **Comment Letter on the CEJS Tool**

- The proposed <u>Climate and Economic Justice Screening Tool</u>:
  - Is meant to "help Federal agencies identify disadvantaged communities that are marginalized, underserved, and overburdened by pollution"
  - Will inform fiscal investments through the Justice40 Initiative
  - Currently omits race and ethnicity as indicators in identifying "disadvantaged communities"
