

Updates: Council Redesign Proposal

January 30, 2024



The Health Disparities Council is recommending updates to our statute (RCW <u>43.20.270-280</u>), the law that directs our work, to incorporate 17 years of work and learning addressing health disparities in Washington State.



Foundational Truths

- Racism is a public health crisis.
- The COVID-19 pandemic has highlighted and magnified the human cost of health inequities
- Climate change affects us all, exacerbates inequities, and must be addressed through a racial equity and intersectional lens.
- We are interconnected.
- There are many dimensions to health and wellbeing.
- Community holds inherent power.



REDESIGN PROPOSAL

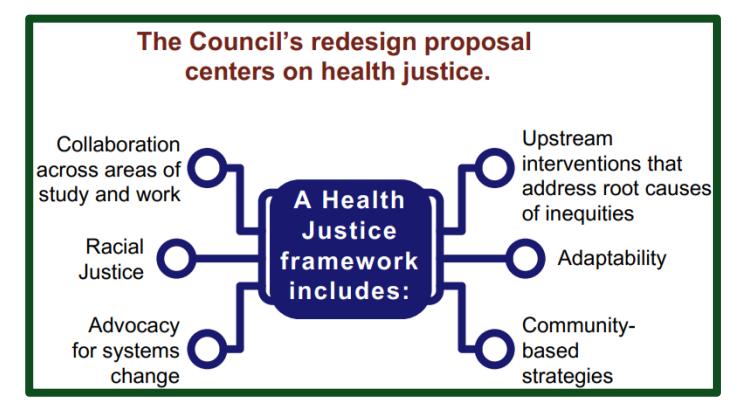
2 COMPONENTS

STATUTORY: request legislation

Update the Council's name, membership, and responsibilities by revising our authority in state law (RCW).

BUDGETARY: decision package

Dedicate adequate funding for Council operations through the State Operating Budget.





UPDATES

- Launched the <u>Council Redesign webpage</u>.
- Published the <u>January 2024 State Action Plan</u> <u>Update</u> report.

Request legislation (bill)

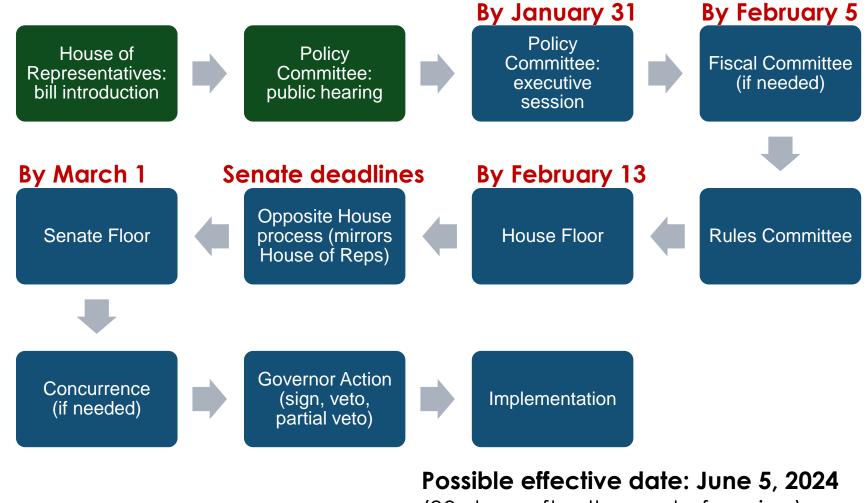
- Revised and approved by the Governor's Office.
- Introduced in the House of Representatives as <u>House Bill 2346</u>.
- Public Hearing on January 23.
- Executive Session (vote) on January 26.

Decision package (fiscal request)

- Incorporated at 60% (approx. \$1.1m/year) in Governor's proposed budget.
- State supplemental operating budget expected by the end of March 2024.



2024 Legislative Process for HB 2346



(90 days after the end of session)

Governor's 2024 Proposed Budget

• We may receive funding before the bill would go into effect (if passed).

COUNCIL BASE OPERATING FUNDS (unconfirmed)

- FY 2024 (use June 30, 2024): \$56,825
 - 0.34 FTE staff beginning in April 2024
- FY 2025 (July 2024 June 2025): \$1,106,616
 - Council Manager + 4.5 FTE staff
 - Meetings/forums
 - Language access
 - Additional goods and services (training; AV equipment; AAG)
- FY 2026 & 2027: **\$1,195,547 per year**
 - Council Manager + 5.0 FTE staff
 - Funds to support meetings, engagement, language access, etc.

Possible Outcomes from Legislative Session

Request Legislation (statutory changes)

		Adopted	Not Adopted

Funding	Not Adopted	OUTCOME 3: Updated statute No/little additional funding	OUTCOME 4: Current statute No/little additional funding

Note: We cannot be certain of the exact statutory changes / funding amount until the end of legislative session.
