
GOVERNOR'S INTERAGENCY COUNCIL ON HEALTH DISPARITIES

COUNCIL REDESIGN

Recently, the Council worked on a <u>redesign project</u> to propose changes to our name, structure, and responsibilities. Various partners in government and community offered insight, including how to better engage communities and align with partners' priorities.

The Council's <u>January 2024 report</u> describes the redesign process and makes recommendations to the Governor and state lawmakers to move the state toward health justice and equity. Recommendations include:

- Update the Council's membership, responsibilities, and name (to Governor's Council for Health Justice and Equity) by revising the state law (statute) that directs the Council's work.
- Provide adequate funding through the state's operating budget to support the Council's operation.

Revising the Council's statute and budget requires approval by state lawmakers and the Governor during legislative session. The 2024 Legislative Session took place between January – March 2024.

LEGISLATIVE OUTCOMES:

- The bill to update the Council's statute (<u>HB 2346</u>) received a <u>hearing</u> in the House of Representatives, but did not advance further.
- However, the Council did receive additional funding for our operation, which allows the Council to hire staff for community engagement, policy development, and other needs. This is the first time the Council has received increased state investment since our creation in 2006.



The Council is responsible for identifying priorities and creating recommendations for lawmakers and the Governor to eliminate health inequities by race/ethnicity and gender in Washington.

Guided by our North Star that is Equity, we honor the broad differences and bonding similarities that make up this state. The power entrusted to us by the people inspires us to be channels for change. We shift power by sharing priorities, being transparent and reflective, and disrupting oppressive practices so everyone has the opportunity to thrive.



HEALTH IMPACT REVIEWS

The State Board of Health (Board) conducts <u>Health Impact Reviews</u> (HIRs) in collaboration with the Health Disparities Council.

An HIR is an objective, non-partisan, evidence-based report. It provides the Governor and state lawmakers with information about how policy or budgetary proposals may impact health and equity.

Only the Governor or a lawmaker can request an HIR. State agencies and community organizations have used information from HIRs in their own work.

Since July 2023, Board staff have written eight HIRs on topics like residential rent increases, regulation of commercially harvested crab for biotoxins, birth doula certification, and the purchase of zero-emission school buses.

All HIRs are available to the public on the Board's HIR website.
