
## What is Health Justice?

- Framework for health law and policy scholarship
  - Subordination as the root cause of health inequities
  - o "...role of laws, policies, and institutions in creating, perpetuating, and (potentially) dismantling subordination within health care, public health, and beyond"

- - Collective ethic of care
  - Considers social justice as "a core value of health law and policy"
  - (SDOH)



## Historical Context

**1972:** The Black Panthers demanded an end to the economic and racial-based disparities through access to healthy foods, adequate housing, and healthcare

2005: World Health Organization launched the Commission on Social Determinants of Health to explore health inequities and better social conditions for health

1985: The Heckler Report – first large scale health study of minoritized groups

2003: First National Healthcare Disparities Report

1986 – 1988: U.S. Office of Minority Health created

1990: Americans with Disabilities Act (ADA) signed into law

2018: Network for Public Health Law conference on "Health Justice: Empowering Public Health and Advancing Health Equity" (NPHL 2018).

2019 - Current: Stark inequities in Covid-19 infections, disease outcomes, and access to healthcare are linked to inequities in healthcare systems and throughout society

### GOVERNOR'S INTERAGENCY COUNCIL ON HEALTH DISPARITIES

"...the time is now to shift the research emphasis away from solely documenting the pervasiveness of the health disparities problem and begin focusing on health equity, the highest level of health possible." (Srinivasan 2014)

"Ensure there is action and address the root causes instead of recycling what we already know. Don't perpetuate the hierarchical structures that got us to where we are right now."


# Example: Applying a Health Justice Approach

### In the first half of $2020^3$ :

- 37% of Americans (and 48% of people who were uninsured) with medical debt used up all their savings to pay medical bills
- 40% received a lower credit rating because of their medical debt
- 1 in 4 people could not pay for basic necessities such as food, heat, or rent
- People of color, people with low incomes, and young adults were more likely to be uninsured or underinsured

### Strategies<sup>4</sup>:

- Use public awareness and engagement campaigns that relate to people's experiences
- Do grassroots organizing to shape solutions and advance change alongside communities most impacted
- Build coalition power by working across movements (e.g., economic justice partners)
- Advance policy changes at the state, federal, and systems levels that address the root causes of healthcare costs



# Principles of Health Justice

- A framework for health justice is still emerging.
- Six aspects of a health justice framework<sup>10</sup>:
  - 1. Collaboration across areas of study and work
  - 2. Upstream interventions that address root causes
  - 3. Adaptability
  - 4. Racial justice
  - 5. Advocacy for systems changes
  - 6. Community-based strategies






# What is Targeted Universalism (TU)?

Targeted universalism: "setting universal goals pursued by targeted processes to achieve those goals."

- Avoids seeking parity with the demographic majority and instead uplifts all of us.
- Strategies "are targeted, based upon how different groups are situated within structures, culture, and across geographies to obtain the universal goal."
- "potential for ingenuity and boldness in policy thinking...that rejects an 'either-or' approach."



# What is Targeted Universalism? (continued)

- Outcome-oriented processes that are "in service of the explicit, universal goal."
- "[R]ejects a single or even a limited number of targeted implementation strategies toward a universal goal."
- Requires "development of a range of implementation strategies" focused on:
  - Addressing barriers faced by different groups and populations
  - Creating structures that promote the desired outcome for different groups

## Strategies from Targeted Universalism

- Promotes bridging and interconnectedness
- Everyone sees themselves as part of an aspirational goal
- Dismantle structural barriers
- Co-design new structures for opportunity and thriving
- Accountable to meeting everyone's needs



## 5 Steps for TU

From the Othering & Belonging Institute:

- 1. Establish a universal goal based upon a broadly shared recognition of a societal problem and collective aspirations.
- 2. Assess general population performance relative to the universal goal.
- 3. Identify groups and places that are performing differently with respect to the goal. Groups should be disaggregated.
- 4. Assess and understand the structures that support or impede each group or community from achieving the universal goal.
- 5. Develop and implement targeted strategies for each group to reach the universal goal.



### 1. Framework for health law and policy scholarship

- Names subordination as the root cause of health inequities
- Centers "role of laws, policies, and institutions in creating, perpetuating, and (potentially) dismantling"<sup>3</sup> inequities and subordination

### 2. Movement for power building and transformational change

- Collective ethic of care
- Considers social justice as "a core value of health law and policy"<sup>3</sup>
- Health care access as one of many social determinants of health (SDOH)



- Avoids seeking parity with the demographic majority and instead uplifts all of us.
- Requires developing and implementing tailored strategies for each group to reach the universal goal.

### **TU Strategies:**

- 1. Promote bridging and interconnectedness
- 2. Everyone sees themselves as part of a bigger goal
- 3. Dismantle structural barriers
- 4. Co-design new structures for opportunity and thriving
- 5. Be accountable to meeting everyone's needs
