HB 1174 Concerning court interpreters

### **Global Workforce Survey of Healthcare Interpreters**

For the first time ever, the Certification Commission for Healthcare Interpreters (CCHI) is mapping the entire medical interpreter workforce serving U.S. patients and healthcare providers through a groundbreaking Global Workforce Survey of Healthcare Interpreters. This historic effort aims to bring transparency to the profession, and interpreters worldwide are invited to share their experiences. This survey represents the most comprehensive study ever conducted on the profession.

The survey seeks input from interpreters working in any location - whether in-person or remotely - who facilitate communication in medical encounters in the U.S. including those who work full-time, part-time, or occasionally, across settings such as hospitals, clinics, insurance assessments, or legal-medical contexts, and encompasses both spoken and sign languages.

Participants will provide insights on their employment status, compensation, and job satisfaction. The data collected will spotlight real working conditions and pay, support advocacy efforts and help demonstrate interpreters' value to the organizations they serve.

This is a pivotal moment for the profession—contribute to meaningful change, take the survey, and help shape the future of their field and ensure YOUR voice is heard! ## Final Rules Issued on Accessible Labeling for Prescription Medicines

On January 22, 2025, the Pharmacy Quality Assurance Commission of the WA State Department of Health filed a rules adoption package (CR-103P) under WSR 25-04-003 amending a section of rule — WAC 246-945-015 Minimum Requirements for Dispensing Practitioners — and creating four new sections of rule: WACs 246-945-026 Accessible Prescription Information — Definitions, 246-945-027 Accessible Prescription Information, 246-945-028 Accessibility of Prescription Information for Visually Impaired or Print Disabled Individuals, and 246-945-029 Translation and Interpretation for Prescription Information for LEP Individuals. The rule takes effect on January 22, 2027.
